This has reference to Regulation 30 of the SEBI (Listing Obligation and disclosure Listing Requirements) 2015, Regulations, hereinafter referred as ("Listing regulations"), where we hereby inform you that, Company has received order from the office of the Additional Commissioner, Grade II Appeal, Central Goods and Services Tax, Moradabad, Uttar Pradesh on i.e. April 30, 2026 wherein, the authority has raised consolidated demand of Rs. 53,28,932/- (Duty Demand of Rs. 23,42,902/-, Interest of Rs. 27,51,740/- and penalty of Rs. 2,34,290/-) on the Rana Sugars Limited, Village Belwara, Moradabad, Uttar Pradesh for the alleged violation w.r.t. e-way bill, excess quantity of Molasses and free distribution of bio-compost for Financial Year 2019-20.

Further, the information pursuant to Regulation 30 of Listing Regulations read over with SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015, Circular no. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 and para 8.2 of Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, to the extent applicable to the matter, is as follows:

- a. **Name of the authority:**
Additional Commissioner, Grade II Appeal, Central Goods and Services Tax, Moradabad, Uttar Pradesh
- b. **Nature and details of the action(s) taken, initiated or order(s) passed:**
A consolidated demand of Rs. 53,28,932/- (Duty Demand of Rs. 23,42,902/-, Interest of Rs. 27,51,740/- and penalty of Rs. 2,34,290/-) on the Rana Sugars Limited, Village Belwara, Moradabad, Uttar Pradesh for the alleged violation w.r.t. e-way bill, excess quantity of Molasses and free distribution of bio-compost for Financial Year 2019-20.
- c. **Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority:**
The demand and penalty order is received on 30th April, 2026.
- d. **Details of the violation(s)/contravention(s) committed or alleged to be committed:**
Violation alleged for cancellation of e-way bill and delayed re-generation of the same. Excess Quantity detected in quantity of Molasses and distribution of bio-compost.

e. **Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible:**

Based on Company's assessment, the aforesaid demand is not maintainable as the Company has already replied to the queries of the Department. The Department has not considered our replies and issued the said Order.

However, the Company is evaluating all options including filing an appeal against the order before Tribunal/Appropriate Authority.

Lastly, as the Company is having a strong case, the Company did not envisage any relevant impact on financials, operations or other activities of the Company.
